智易科技股份有限公司(股票代號:3596)本日(6/7)公佈民國110年5月份合併營收。5月份合併自結營收為新台幣30.84億元,較上月減少5.9%,較去年同期增加25.9%;累計110年1至5月合併自結營收為新台幣159.88億元,較去年同期增加28.2%。

5月受到不同產品出貨組合改變之影響,營收較 4 月略為減少,但仍較去年同期大幅增加,並創下歷年來同期新高紀錄。智易仍然審慎樂觀看待第二季訂單狀況,目前中國及越南工廠營運一切正常,將持續強化供應鏈之管理,密切掌握供料狀況及交期。

智易係以研發為導向的公司,將持續擴編研發團隊及招攬優秀人才。除了持續開發 Wi-Fi 6、Wi-Fi 6E、DOCSIS 3.1 Cable Modem、XGS PON 光纖、STB、5G CPE 等既有產品線及新一代寬頻技術之外,將加重投資力道研發 5G應用領域(行動小基站、邊緣計算及垂直市場)、AIOT、Cloud 及車聯網等新領域。

Arcadyan Technology Corporation (3596.TW) today reported May 2021 consolidated revenue of NT\$3,084mn, representing MoM decrease of 5.9% and YoY increase of 25.9%. The accumulated revenue of 2021 was NT\$15,988mn, representing YoY increase of 28.2%.

Due to different combination of products, the revenue of May 2021 was slightly decreased from April 2021. However, the revenue of May 2021 was still increased significantly from May 2020 as well as hit the record high for the same period. Arcadyan still remains cautiously optimistic to the orders for the second quarter of 2021. Currently, the factories in China and Vietnam are operated normally. Arcadyan will keep enhancing the management of supply chain and monitor closely for the supply and delivery of materials.

Arcadyan is a R&D-oriented company and will continue to expand its R&D team as well as recruiting outstanding talents. Arcadyan not only continue to develop Wi-Fi 6, Wi-Fi 6E, DOCSIS 3.1 Cable Modem, XGS PON fiber, STB, 5G CPE and new-generation of broadband technology, but also increase investment in new products and technologies such as 5G applications(e.g. Small cell, MEC and vertical market), AloT, Cloud, and automotive related products.
